What is the Personalized Education Program (PEP)?

The Personalized Education Program (PEP) is a Florida scholarship program that provides eligible families with an Education Savings Account (ESA) to customize their child's education. PEP allows parents to direct their child's educational experience by selecting approved educational services, curriculum, instructional programs, and other qualifying educational expenses.

PEP Enrollment at Christian Academy for Autism

Christian Academy for Autism welcomes eligible PEP students seeking a supportive educational environment specifically designed for students with unique learning needs.

PEP students may have access to: Specialized academic instruction, small-group learning environments, social skills development, executive functioning support, enrichment activities, individualized educational planning, parent collaboration and communication, and structured classroom environments designed to support student success.

Parent Responsibilities

The Personalized Education Program is a parent-directed scholarship program. Parents are responsible for maintaining scholarship eligibility, complying with all Step Up For Students requirements, completing all required documentation, maintaining any required Student Learning Plans, meeting scholarship deadlines, completing required assessments, and monitoring scholarship account activity.

Attendance and Participation Requirements

Christian Academy for Autism offers full-time, part-time, and hybrid educational options for eligible students participating in Florida's Personalized Education Program (PEP).

Students are expected to attend and participate in all educational services for which they are enrolled. Attendance requirements are based on each student's individual enrollment schedule and may vary depending on the services selected by the parent.

Parents remain responsible for maintaining compliance with all Florida Department of Education and Step Up for Students requirements, including any applicable attendance, participation, assessment, and documentation obligations associated with the PEP scholarship.

Christian Academy for Autism monitors attendance and participation for all scheduled educational services. Excessive absences, failure to participate in scheduled instruction, or failure to comply with scholarship requirements may affect continued enrollment and scholarship eligibility.

Tuition and Scholarship Payments

Eligible educational services may be submitted through approved scholarship payment systems when permitted by scholarship guidelines. Parents are responsible for maintaining sufficient scholarship funding, timely approval of scholarship payments, any tuition balances not covered by scholarship funds, and ensuring all required payment authorizations are completed within designated deadlines.

Important Notice

Participation in educational services at Christian Academy for Autism does not transfer responsibility for scholarship compliance from the parent to the school. Parents remain solely responsible for maintaining scholarship eligibility, completing required documentation, meeting assessment requirements, and complying with all applicable scholarship rules.
